The Endow Iowa tax credit program allows donors who start or give to an Endow Iowa qualified fund, such as the Cari Farver Memorial Scholarship Fund, to be eligible to receive a 25% Iowa tax credit, in addition to a federal charitable income tax deduction. As an extra bonus, the Pottawattamie County Community Foundation will add a 10% contribution to the fund. All donations to the Pottawattamie County Community Foundation are fully tax deductible, as allowed by law.
